
# Election 2007: Hamlin supervisor

## Two issues of primary importance in Hamlin

There are a multitude of issues. Of primary importance, because it affects all the other issues and all the residents, is the need to keep taxes low by increasing our tax base and reducing our spending. We have taken steps to increase our tax base by encouraging development where it least impacts our productive farmland and our sensitive environment. We have limited spending and worked inter-municipally in order to save money without reducing services. We must continually address this dual challenge - increasing our tax base and reducing our spending – to maintain low taxes into the future.

A resident stated, "I would have to have been locked in my basement" to not know wind towers is an issue. With multiple truths involved, pro and con, it's very emotional and led to false insinuations and accusations tarnishing the character of town officials and residents on either side. Town Board is prudently acting to have effective regulations - which must balance rights of landowners with the welfare and safety of the town, environment and non-participating landowners - in place so that town officials, not outside developers or remotely located State officials, have the final say on if and where towers can be installed.

#### Why I am seeking reelection?

I am seeking reelection because I am the most qualified candidate for the position, because I enjoy public service, particularly the ability to assist the residents of Hamlin, and because there are many challenges still to be addressed, which I desire to contribute to resolving.

What have you accomplished during your two years in office? Full-time servant filling part-time position, averaging 50 hours per week doing town business.

Declined benefits to reduce expenses. Transferred excess to the library.
