Issues of primary importance in Chili:

1. Maintaining stable taxes and spending and 2. maintaining the delicate balance between growth and preserving residents quality of life. One key to our efforts to control town taxes and spending is to carefully manage and encourage commercial development in areas where it is appropriate and not negatively impacting residential neighborhoods. By bringing new business to Chili, and supporting the expansion of existing employers, we can help create and maintain jobs, grow our tax base and lessen the burden on residential property taxpayers.

Why I am seeking re-election

As supervisor for the past 4 years, I have had the opportunity to deal with the complexity of needs and issues that confront a growing community. Chili's growth potential has been recognized and commercial businesses have identified our area as an underserved residential population with future growth potential. What I wish you had asked

What can you do about my assessment going up? As elected officials, it is illegal for us to interfere with the Town Assessor or the amount of the assessment. Town sssessors are appointed for 6 year terms. The State of New York makes sure that all towns are assessed at 100% of re-sale value. If houses in a given area are selling for significantly higher than the assessed value of the houses in that section, the state "red flags" that area as under assessed and the Assessor's Office must re-assess that section or the town will be billed by the state for the higher tax amount they say is due. It is against the law for an elected official to intervene.

Issues of primary importance in Chili:

Providing quality services while being fiscally responsible will continue to be a primary focus for me. Since I have been councilwoman, we have had a stable tax rate, paid cash for new purchases and have paid off some loans early.

Why don't we have more restaurants and a hotel in town instead of multiple pharmacies, pizza and donut shops?

If land is zoned for a certain type of development, a municipality cannot deny them the right to build. The town can set conditions on hours of operation, design, signage, etc., through the Planning Board, but it cannot legally prevent them from building. A town also cannot force a business to locate within Chili. Multiple requests have been made for restaurants and a hotel, but ultimately, it is the business's decision.

What control does the Town Board have over the Library and their budget?

The Library consists of a director and a board of trustees. They are responsible for creating and proposing a budget to the town -board for approval. The town board cannot tell the library how to spend their budget. The funding for the library comes for the tax levy which is set by the town board. The library is also a Not-for-Profit organization and has many volunteers that assist the paid staff in the operation of the library which reduces the cost to tax payers. This is similar to the volunteer fire departments. What makes Chili such a wonderful place to live and raise a family is the quality of life that we have and the library contributes to this.
